PUBLIC BRIDLEWAY DIVERSION ORDER 2019

This Order is made by Leicestershire County Council ("the authority") under Section 119 of the Highways Act 1980 (hereinafter called "the 1980 Act") because it appears to the authority that in the interests of the owner of the land crossed by the bridleway and described in paragraph 1 of this Order it is expedient that the line of the bridleway should be diverted.

Harborough District Council has been consulted and has consented to the making of the Order as required by Section 120(2) of the 1980 Act.

BY THIS ORDER

1. The public right of way over the land situated at Quenby Hall, Hungarton and shown by a bold continuous line on the map contained in this Order and described in Part 1 of the Schedule to this Order shall be stopped up after 30 days from the date of this Order.
  
2. Notwithstanding anything contained in paragraph 1 where immediately before the date on which the public right of way referred to therein is diverted in pursuance of this Order, there is apparatus on, under or over the right of way belonging to statutory undertakers, for the purpose of carrying out their undertaking, the undertakers shall continue to have the same rights in respect of the apparatus as they then had.

3. There shall at the end of 30 days from the date of confirmation of this Order be a public Bridleway over the land at Quenby Hall, Hungarton described in Part 2 of the Schedule and shown by a bold broken line on the map contained in this Order.
4. Notwithstanding the provisions of Article 1 these provisions for the extinguishment of the public right of way shall not come into force until the Leicestershire County Council acting by its proper officer shall have certified that the agreed works have been carried out to its satisfaction in accordance with Section 119(3) of the 1980 Act.
5. This Order may be cited as the "Leicestershire County Council (Public Bridleway D6 (part) and D43 (part) at Quenby Hall, in the Parish of Hungarton and the District of Harborough) Public Path Diversion Order 2019."

## SCHEDULE

### PART I

#### DESCRIPTION OF SITES OF EXISTING WAYS

##### Description of site of Bridleway D6 to be diverted

That part of Bridleway D6 at Quenby Hall Park in the Parish of Hungarton, and the District of Harborough, shown by a bold continuous line on Plan No. 2483 annexed hereto, which extends from point "A" on the plan, situate at Grid Reference 46976 30635, in a generally easterly direction along the Avenue leading to Quenby Hall for a distance of approximately 90 metres to point "I" on the plan situate where the path crosses an ornamental bridge at Grid Reference 46985 30635 and then continues in a generally easterly direction along the Avenue for a distance of approximately 220 metres to point "B" on the plan situate at Grid Reference 47007 30637 and then continues in generally south-easterly and east-south-easterly directions in a curve around the south side of Quenby Hall across grassland for a distance of approximately 170 metres to point "C" on the plan situate at Grid Reference 47021 30629 and then continues in generally east-north-easterly and north-easterly directions across grassland for a further distance of approximately 225 metres to point "D" on the plan situate at its junction with a track at Grid Reference 47039 30641 and then continues in a generally easterly direction along this track for a further distance of approximately 220 metres to point "E" on the plan situate at Grid reference 47061 30638. (As depicted A-I-B-C-D-E on the plan)

*The section of Bridleway to be diverted has no recorded width.*

##### Description of site of Bridleway D43 to be diverted

That part of Bridleway D43 at Quenby Hall Park in the Parish of Hungarton, and the District of Harborough, shown by a bold continuous line on Plan No. 2483 annexed hereto, which extends from point "H" on the plan, situate at Grid Reference 46958 30614, in a generally north-easterly direction diagonally across ridge and furrow pasture land, for a total distance of approximately 340 metres to point "I" on the plan, previously described. (As depicted H-I on the plan)

*The section of Bridleway to be diverted has no recorded width.*

### PART II

#### DESCRIPTION OF SITES OF NEW WAYS

##### Description of site of new Bridleway D6 to be created

A new public bridleway (D6) at Quenby Hall Park, in the Parish of Hungarton and the District of Harborough, shown by a bold broken line on Plan No. 2483, which will extend from point "A" on the plan, previously described, in a generally east-south-easterly direction, along a grassy track for a distance of approximately 90 metres to point "F" on the plan situate at Grid Reference 46985 30633 and then continues in a generally south-easterly direction along a grass and gravel track for a distance of approximately 375 metres to point "G" on the plan situate at Grid Reference 47011 30606 and then continues in generally easterly and then north-easterly directions along the grass and gravel track for a further distance of approximately 610 metres to point "E" on the plan, previously described.

(As depicted A-F-G-E on the plan)

The new bridleway will have a width of 4 metres.

Description of site of new Bridleway D43 to be created

A new public bridleway (D43) at Quenby Hall Park, in the Parish of Hungarton and the District of Harborough, shown by a bold broken line on Plan No. 2483, which will extend from point "H" on the plan, previously described, in a generally north-north-easterly direction, along a grassy causeway between areas of ridge and furrow for a distance of approximately 250 metres to point "J" on the plan situate at a new junction with the Avenue at Grid Reference 46969 30636. (As depicted H-J on the plan)

The new bridleway will have a width of 4 metres.

Existing bridle gates at Grid References 46985 30633 and 47011 30656.

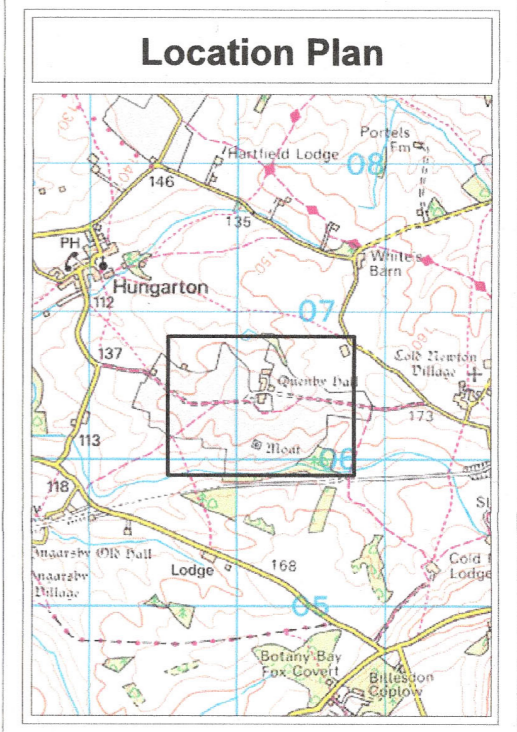

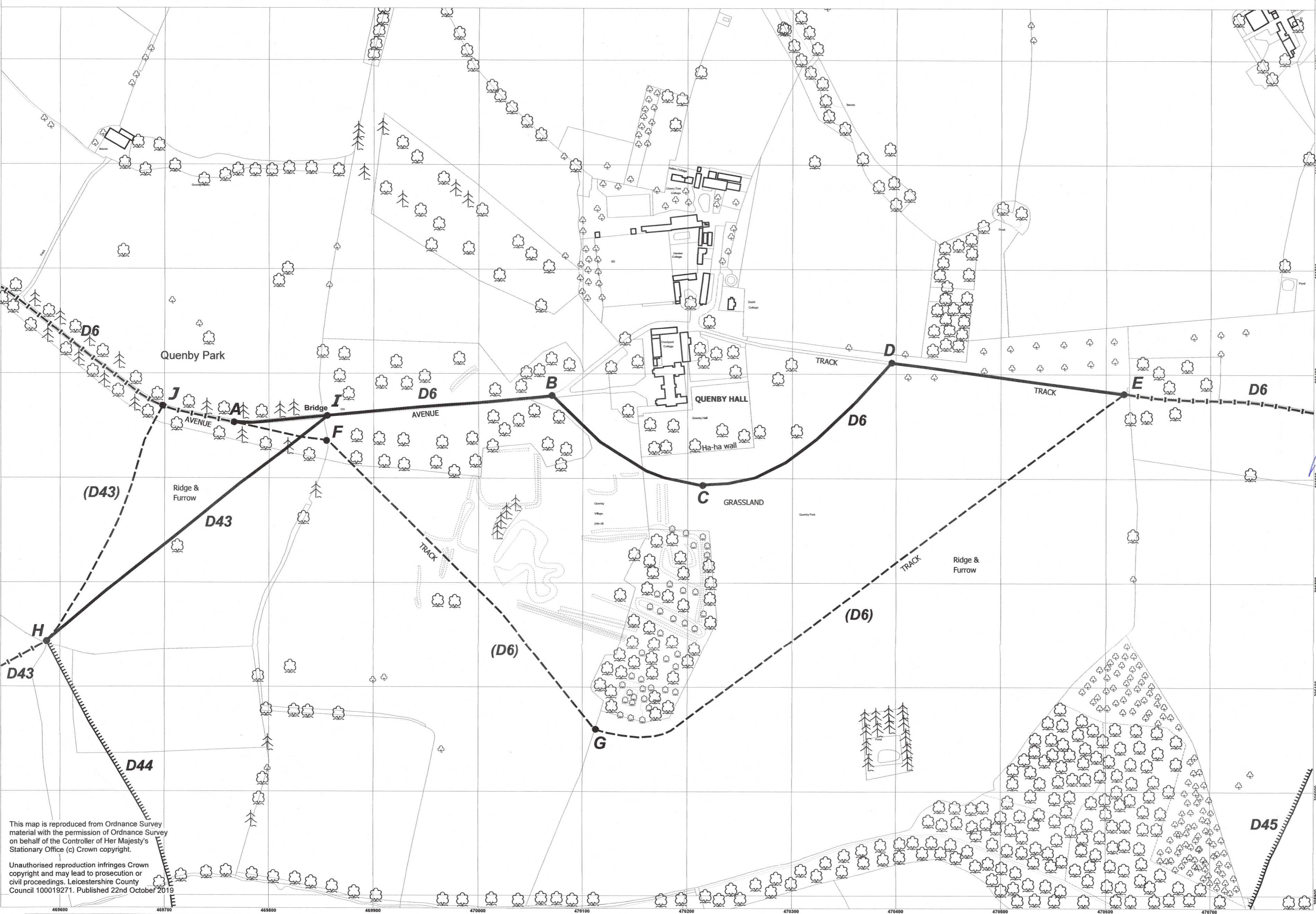
